# Wilmington Bands Parents and Friends Association <br> BYLAWS 

| ARTICLE 1 | THE NAME OF ORGANIZATION <br> A. The name of this organization shall be the Wilmington Bands Parents and Friends Association. <br> B. Organization could also be referred as an abbreviated name of "Wildcat Band Parents" for media purposes. |

| ARTICLE II | PURPOSE OF ORGANIZATION <br> The purpose of this organization shall be to provide additional support for the Wilmington Public Schools Wildcat Bands and its Instrumental Music programs (Grade 4 thru 12). |
| ARTICLE III | MEMBERSHIP <br> A. Membership is open to any interested person who is not currently a student in the Wilmington Public Schools and has a student in the Wildcat Bands program. <br> B. An Active Member shall be any member who regularly participates in this organization's activities and projects. |
| ARTICLE IV | MEETINGS <br> A. Regular scheduled meetings will be held monthly and are held as needed during the summer. The day and time will be set at the previous meeting. <br> B. Notices of meetings, including notice of any special events, will be made public through social media sites and email distribution to subscribed Band Parents' newsletter email list. <br> C. In the absence of the President, the Vice-President shall preside. In absence of both above, the meeting will be postponed. |
| ARTICLE V | VOTING AT GENERAL MEETINGS <br> A. Any active member present is eligible to vote on an issue. <br> B. Votes are carried by simple majority. |
| ARTICLE VI | OFFICER ELECTIONS <br> A. Officers of the organization shall include President, Vice-President, Secretary, Treasurer, and Publicity Director. <br> B. Term of office for the officers shall be for two years starting in June. <br> C. In the event of any officer leaving office during their term, the members shall elect, by majority vote, a replacement at the next regular meeting following the vacancy. Persons shall be nominated by the remaining officers to be presented to the membership. Nominations shall be made from the floor. <br> D. If a vacancy occurs in the office of President, the Vice-President will become President and a new Vice-President will be elected at the next meeting. <br> E. Nominees for office must be "Active" Members. <br> F. Elections will be held bi-annually in April by anonymous online ballot. <br> G. A notification of the election will be sent to the Band Parent Community in March of the election year. |

## ARTICLE VII DUTIES OF OFFICERS

## PRESIDENT

A. The President shall hold meetings as necessary with other officers to discuss business and set the agenda for the following meeting.
B. The President shall oversee all functions and preside over regular meetings.
C. The President has access to the bank account along with Treasurer.
D. The President manages the PO Box at Wilmington Post Office with the Treasurer.
E. The President represents the organization at events including fundraisers, scholarship night and other events as necessary.

## VICE-PRESIDENT

A. The Vice-President shall preside in the absence of the President.
B. The Vice-President shall assist the President when requested for any duties prescribed.
C. The Vice-President shall attend all officers' meetings as called by the President.
D. The Vice-President will assist the President with fundraising events and activities.

## SECRETARY

A. The Secretary shall keep the minutes of each regular meeting.
B. The Secretary shall attend all officers' meetings as called by the President.
C. The Secretary shall submit a copy of previous month's minutes for approval to President.
D. The Secretary shall maintain any necessary correspondence.

## TREASURER

A. The Treasurer shall keep all financial records this organization.
B. The Treasurer shall choose, with approval of officers, the bank in which to maintain funds and receive all bank records while maintaining accounts.
C The Treasurer shall present a report of all funds at each regular meeting for approval of members.
D. The Treasurer shall pay bills as requested by either vote of officers or vote of members present at any regular meeting.
E. The Treasurer shall attend all officers' meetings as called by the President.
F. The Treasurer manages the PO Box activity along with the President.
G. The Treasurer provides the petty cash box to all events and calculates the funds raised reporting to the officers after fundraising activities.

## PUBLICITY DIRECTOR

A. The Publicity Director shall oversee all notices and publicity releases.
B. The Publicity Director shall attend all officers' meetings as called by the President.
C. The Publicity Director manages all social media including but not limited to Facebook, Twitter, Website and other electronic means of distribution such as MailChimp for newsletter and notifications.
D. The Publicity Director maintains the database of email address for Band Parents who have subscribed to receive notifications.

## ARTICLE IX EXPENDITURE POLICY

A. Expenditures require a general membership vote.
B. The officers will work in an advisory capacity with the Band Director(s) to explore suggestions for the use of funds.
C. Unforeseen Expenditure(s) -up to $\$ 150$ - to be discussed at next meeting for full disclosure of associated expenses.
